A. COSM1100 Principles and Practices: Cosmetology

B. COURSE DESCRIPTION:

This course is for Cosmetology students. This course will meet preclinical requirements for licensure. Students will focus on the topics of chemistry, electricity, professional image, anatomy, infection control and Minnesota statutes and rules.
(3 Cr – 1 lect, 2 lab)
