A. COSM 1135 Licensing Preparation: Cosmetology

B. COURSE DESCRIPTION:

This course prepares students to take the general theory, state and written practical exams that are required for licensure. Topics include safety and infection control, client consultation and professional conduct, hair, skin and nail anatomy and disorders, hair styling, hair cutting, chemical services, nail care service and skin care services and Minnesota statutes and rules.
(3 Cr – 0 lect, 3 lab)
