A. PNUR 1190 Clinical II

B. COURSE DESCRIPTION:

Clinical II provides the student an opportunity to apply nursing judgment using evidence-based care, critical thinking and clinical judgment to implement safe, patient/relationship centered care to individual patients across the lifespan (including maternal/child/pediatric). The clinical student reflects on the value of patient centered care, teamwork and collaboration, informatics, quality improvement, safety, managing care of the individual patient, and nursing judgment/evidence-based care in his/her career as a LPN. Pre-requisites: PNUR 1110, PNUR 1120, PNUR1130, PNUR1140. Co-Requisites: PNUR1150, PNUR1160, PNUR1170, PNUR1180.
