A. CRJU 1210 Criminal Justice Career Development

B. COURSE DESCRIPTION:

A career in Criminal Justice involves an extensive hiring process. Requirements are mandated by law under *Minnesota Rules*, Chapter 6700.0300. This includes the application, testing, multiple interviews, extensive background investigations, physical agility testing, medical exam, and a psychological exam. This course addresses the entire process and instructs students on ways to best prepare to be considered for employment. This instruction is ongoing and progressive throughout the entire year.

Criminal background checks (at the student's expense) are a requirement for enrollment in this class and must be conducted at the beginning of the semester. *Minnesota Rules*, Chapter 6700.0300, subp.5(D), requires all students be advised in writing of minimum selections standards that must be met to become a licensed peace officer in Minnesota. Students are advised of these standards in order to make informed decisions about participation in the professional peace officer education program. *Minnesota Rules* 6700.0700 defines the Minimum Selections Standards for Peace Office Licensure. Please consult the Program Coordinator or the rules cited above for further information. This course is designed for Criminal Justice declared major students only. This course is an ongoing course.
